Our vision is to be a leading child and family development center working with Head Start families and community partners in Lewis and Clark, Broadwater, and Jefferson counties, to promote healthy life choices and to develop skills necessary for academic and social success.



Head Start at Rocky Mountain Development Council, Inc. (Rocky) has a dedicated staff of 40+ working with our federally funded number of 125 children and their families in the tri-county area (Lewis and Clark County, Broadwater County and Jefferson County). In program year 2023-2024 the program celebrated its 56th year of existence in the tri-county area. The program operated a center-based option at seven sites that housed 11 classes.







#### **FINANCIAL REPORT - REVENUE**

Rocky Mountain Development Council, Inc.'s (Rocky) audit for FY23 was performed by KCOE ISOM, LLP. Rocky's FY23 financial statements, including single audit compliance, were issued on March 19, 2024 with an unmodified "clean" opinion and there were no findings.





To be a supportive and safe learning environment for children and families by enhancing their sense of belonging and selfworth while encouraging them to reach their highest potential.

Head Start is a comprehensive early childhood development program that serves low-income children ages three to five and their families. Head Start focuses on physical and oral health, positive social/emotional development, healthy nutrition, and access to a stable, nurturing, and encouraging environment and the roles they play in preparing children for success in school and life. Head Start also focuses on supporting families to identify their strengths, work toward their goals, and recognize and build on their efforts to be their child's first and most important teacher. Head Start uses two specific curricula: Creative Curriculum® for Preschoolers, Second Step® Social Emotional Learning Program and Second Step® Child Protection Unit. Every activity throughout the day provides an educational opportunity for a child in or out of the classroom, whether it is growth in relationship building, how a child perceives him/herself, the ability to sort and categorize, set a table, pass food and pour milk, to share, recognize their name or letters, expand their vocabulary, or listen and follow directions. Much of this is achieved through play, the "work" of children. Rocky Mountain Development Council, Inc. (Rocky) is the local Human Resource Development Council for District 8 and has been the grantee agency for the Head Start Program since 1967. Rocky Head Start currently serves 16 children and their families in Broadwater County, 13 in Jefferson County, and 96 in Lewis and Clark County. Ninety percent of all children enrolled in Head Start must meet Head Start income guidelines, 10% of Head Start's openings must be for children with disabilities.





### **BOARD OF DIRECTORS & POLICY** COUNCIL

As required by regulation, Head Start is governed by a Board of Directors and a Policy Council. The Board of Directors holds overall legal and fiscal responsibility for the organization. The Policy Council is made up of parents/guardians of children currently enrolled in Head Start and community representatives. The Board and Policy Council work with Head Start's key management staff to ensure the program meets the needs of children, families and communities where Head Start is located.



#### **STATISTICS**

During the 2023-2024 school year, our Head Start program was funded to serve 176 children and their families in Lewis & Clark. Broadwater and Jefferson Counties. Two hundred twenty-nine applications were scheduled from January 1, 2023 through December 31, 2023. Of those applications scheduled one seventy-two were completed and of those applications one hundred three students were enrolled. Sixty-nine families were left on the waitlist with thirty-eight of those families on the waitlist being over-income. Of these families served 91% of children served met Head Start Eligibility guidelines (Homeless, foster, Public Assistance, 0-100% of Poverty), 3% 101%-130% of poverty, 6% over 130% of poverty and our average monthly enrollment was 58% or 103 of the 176 funded enrollment.



\*In the 2023-2024 year, Rocky Head Start was funded to open 11 classes, serving 176 children. Due to staffing issues, Rocky Head Start was only able to open 7 classes. Of funded enrollment, average monthly enrollment was 58% (103/176). Of actual possible enrollment in the 7 classes, average monthly enrollment was 92%



Parents are their child's first and most important teacher. Family Advocates partner with each child's family to build a foundation for school readiness, coordinating with education staff and community partners. Head Start Family Advocates meet with every Head Start family. Visits may occur in a family's home, in the child's classroom, or other community settings. During theses visits, they work alongside families as they identify strengths and set goals related to the Seven Family Outcomes. Families typically set goals relating to housing, health, education, parenting, and financial stability. Family Advocate home visits begin at the start of the school year.







Head Start uses The Creative Curriculum® System for Preschool as its primary curricula. Teaching Strategies GOLD<sup>™</sup> is the on-line assessment Head Start uses to monitor children's skills and progress in the areas below. Data is used to drive program decisions on professional development, purchasing of materials and equipment, and family education/events.







# TRANSITION TO KINDERGARTEN

Head Start works to ensure a smooth transition for children "moving on" to kindergarten. Teachers partner with families to set realistic goals for children that will help them be successful. Program staff assists families in filling out their child's kindergarten registration form. Immunization information is given to families to share with their receiving schools.



Each year Head Start staff work with families to prepare a transition profile for each child that provides information about social emotional, cognitive, language and mathematic skills. The profile also includes information regarding screening results and any special health care needs (i.e. medications, asthma, allergies). With parent permission this profile is shared with kindergarten teacher each spring. Head Start collaborates with each of the 15 elementary schools that a majority of children will attend for kindergarten. Kindergarten teachers, administration and support staff meet with Head Start to discuss the individual needs for children as they start in their new school. Our goal is to ensure schools are as prepared as possible to make their first day a positive educational adventure.
